When issued a citation, you <u>must</u> take one of the following 3 actions by <u>the</u> <u>appearance date written on the ticket</u>:

- **1.** <u>Admit Responsibility</u>: Make payment to the 47th District Court via one of the payment options below. The Office of the Secretary of State applies license sanctions (e.g. points, suspensions) based on the charge as outlined in statute.
- 2. <u>Admit Responsibility with Explanation</u>: Submit a letter explaining the circumstances of why you are admitting responsibility to the charge. <u>The judge cannot dismiss or reduce the charge or the corresponding license sanctions</u>. Based on the explanation, the judge may assess the standard fine or a reduced fine. You will be notified of the decision by mail and will have 14 days from the date the Court mails the decision to submit payment.
- **3.** <u>Deny Responsibility and Request a Hearing</u>: You may request either an informal hearing (no attorney representation) or a formal hearing (before a judge with the option for representation and a prosecuting attorney representing the police officer). To deny responsibility and request a hearing, contact the Traffic Division at the telephone number above.

The Court MUST receive your response by the appearance date on the ticket or you will be found in default and an additional \$50 penalty shall be applied to the violation fee.
