OPERATING WHILE INTOXICATED (11-4415)

On August 22nd, at 2:56 a.m., an officer stopped a vehicle on Farmington Road near Shiawassee for tinted windows and speeding. The driver was found to have been drinking at his place of employment (Sliders Bar in Livonia). The driver failed field sobriety tests and was arrested for Operating While Intoxicated (BAC .09%). The driver has a prior conviction for Operating While Intoxicated in 2007.

ASSIST OTHER POLICE DEPARTMENT (11-4424)

On August 22nd, an officer responded to Ram's Horn on a report of an abandoned vehicle. Upon arrival, the officer learned the vehicle had been reported stolen out of Redford on August 13th. The Redford Police Department was notified and the vehicle was towed and held for them for further investigation.

OPEN BURN (11-4441)

An officer was dispatched to Twin Valley on a report of an open burn on the morning of August 23rd. Upon arrival, the officer found a steel drum with brush being burned inside of it. The steel drum did not have a cover and was unattended. The homeowner was located, the fire extinguished and a violation was issued. The homeowner had previously been warned by this department in July 2011.

RESISTING ARREST (11-4452)

On August 23rd, at approximately 9:13 p.m., officers witnessed a male subject driving an All Terrain Vehicle (ATV) down Farmington Road (ATV's are prohibited from driving on the roadway). The male was confronted by an officer and the male admitted that he did not have a valid driver's license. The sergeant who stopped the male escorted the man to his patrol vehicle in order to determine his identity. As the man was being escorted, he broke free from the sergeant and ran into the Meadow's Subdivision. Several officers gave chase to the subject and caught same hiding underneath a pick up truck in the subdivision. The

subject is charged with driving with a suspended license and resisting and obstructing a police officer.

ATTEMPT ESCAPE (11-4467)

On August 24th, at approximately 10:45 a.m., an officer was at Botsford Hospital with a prisoner who was being evaluated for a possible shoulder injury. After being discharged, the officer went to handcuff the subject who then fled. The officer tackled the prisoner as he tried to flee out the doors of the hospital emergency room. The prisoner was then taken into custody without incident and transported back to the Farmington Public Safety Department and housed.

CUSTOMER TROUBLE (11-4472)

On August 24th, an officer was dispatched to a report of trouble between two customers at the CVS Pharmacy on Farmington Road. Upon arrival the officer interviewed one customer who was upset that another customer had cut in front of him. The complainant pointed out the man's rudeness which caused him to threaten to punch the complainant in the face. The man asked the complainant if he wanted to "take this outside" and the complainant refused. No assault had taken place, the man had left the scene prior to the officer's arrival.

LARCENY (11-4474)

On August 24th, an officer was dispatched to a report of a stove and refrigerator stolen out of the yard at a house on Floral Street. Upon arrival the officer learned that the owner of the home had just purchased the home but has not moved in yet. The owner had placed the stove and refrigerator on the side of the garage because they were doing work inside the kitchen. Sometime between August 21st, at 9:00 p.m., and August 22nd, at 7:00 a.m., an unknown person stole the appliances. A neighbor reported seeing a white male driving an older red pick up truck pull into the owner's driveway and look at the appliances. The white male with brown hair knocked on the owner's door but no one was home. The man than returned to his vehicle and drove away.

MALICIOUS DESTRUCTION OF PROPERTY (11-4506 and 11-4507)

While on patrol on August 26th at 9:30 a.m., an officer discovered that the bathrooms at Drake Park and the playground equipment at Longacre Elementary School had been spray painted with graffiti. The area was checked for evidence and photos of the damage were taken.

A short time later the detective bureau was notified and they responded to a possible suspect's home in the area. A member of the detective bureau had taken another Malicious Destruction of Property (MDOP) report earlier in the week and the victims of that MDOP revealed a possible suspect. They made contact with the suspect who confessed to detectives and implicated two others who were involved.

OPERATING WHILE INTOXICATED/OPEN INTOXICANTS IN A MOTOR VEHICLE (11-4520)

On August 27th, at 2:45 a.m., an officer stopped a vehicle for speeding (85 mph in a 70 mph zone) and weaving on M-5 and Farmington Road. The driver admitted to drinking at a bar and failed field sobriety tests. Officers also found a cold, half full bottle of beer in the front seat cup holder. The subject was arrested for Operating While Intoxicated (BAC .12%) and Open Intoxicants.

DISORDERLY INTOXICATION (11-4530)

On August 27th, officers were dispatched to the Owl Laundromat at the World Wide Plaza for a report of an intoxicated male who keeps falling in the parking lot. Upon arrival officers spoke with the manager of the laundromat who advised that the man had fallen in front of the business, and as he was attempting to get up, he repeatedly banged his head into the glass window. The manager asked the man to stop banging his head, which caused him to bang his head more. The man was located at Namaste Flavours Restaurant where three employees said nothing to the officers, but pointed to an obviously intoxicated man leaving a restroom. The man advised that he and a friend had come from Kalamazoo in order to sell some Hindu religious material and that he had consumed too much Cuervo 1800 Tequila. The man had difficulty standing while being interviewed and a preliminary breath test revealed that the man had a blood alcohol content of .16. The man was arrested for disorderly intoxication and was held until he was sober.

MINOR CONSUMED ALCOHOL/LOUD PARTY (11-4533)

On August 28th, at 12:30 a.m., officers responded to a loud party on Maplenut Street. Upon arrival officers made contact with two males who answered the door. The males stated they did not live at the house and did not know who the homeowner/resident was. Officers entered the home and located a resident, a nineteen year old female who was the daughter of the homeowner. The homeowner was not home and the female was found to be intoxicated (BAC .15%). The homeowner was contacted by phone, was unaware of the party and requested all present (except daughter) be removed from the home. The female was issued a violation for Minor Having Consumed Alcohol and the others left the location.

OPERATING WHILE INTOXICATED (11-4534)

On August 28th, at 1:56 a.m., an officer stopped a vehicle on Mooney Street for speeding and driving left of center. The driver stated he had been drinking at a bar in West Bloomfield. The driver failed field sobriety tests and was arrested for Operating While Intoxicated (BAC .13%). The vehicle was turned over to the sober passenger.

OPERATING WHILE INTOXICATED (11-4537)

On August 28th, at 3:40 a.m., officers had contact with five subjects on foot in the

area of Nine Mile and Farmington Road. The subject's vehicle was at 7-11 and they were advised not to drive as they were all intoxicated. The owner of the vehicle took a PBT and was found to have a blood alcohol content of .13%. A short time later an officer observed the vehicle leave 7-11 onto Farmington Road. When the officer pulled behind the vehicle, the driver immediately pulled onto the shoulder of Nine Mile and stopped the vehicle. The officer then observed the female driver climb into the backseat and the car keys were thrown into the grass. When the officer approached the vehicle, there was no one in the driver's seat and the female denied driving. The driver argued with the officer when she was advised of his observations. The driver was arrested for Operating While Intoxicated (BAC .11%). Two of the four passengers confirmed that the female was the driver.

TRESPASSING (11-4550)

On August 28th, officers were dispatched to a report of two men fighting at the Charter One Bank at Farmington Road and Slocum. Upon arrival several residents on Slocum advised that the two men had gotten into a Jeep and left the scene heading east on Slocum Street. Officers checked the area to no avail.

Approximately twenty minutes later officers were dispatched to the Farmington West Apartments for the same two males arguing in the parking lot. Upon arrival the officers located one of the males who advised that he and his friend had been drinking and arguing about paying his share of the groceries. The resident advised that he did not want his friend to return to his apartment and he would press charges for trespassing. Officers advised the male that if he returned that he would be charged with trespassing and he was driven to a local restaurant where he could arrange for a ride home.

Approximately two hours later the resident called this department advising that the male had returned. Officers returned to the complex and were informed that the male took off running when he learned that the police were called. Officers located the male hiding in some nearby bushes. The male was arrested and charged with trespassing.
