



WEEKLY REPORT April 9 – April 15, 2012

POSSESSION OF MARIJUANA/MINOR HAVING CONSUMED ALCOHOL

On April 9th, at approximately 6:53 a.m., officers were dispatched to the Valero Gas Station, Grand River and Orchard Lake Road, for a report of a male lying on the ground shivering. Upon arrival the officers located a sixteen year old male inside the gas station. Officers noted that the teen was covered in mud and had a strong odor of intoxicants on his breath. The teen advised officers that he was at a "tattoo party" somewhere in the city of Detroit when he drank some Cuervo 1800 to ease the pain of receiving a tattoo to his chest. The teen and his friends drove out to Farmington to drop off a friend when the teen decided to leave his friends and walk back home to Detroit. Further investigation revealed that the teen was in possession of marijuana. The teen was turned over to his mother and the incident has been forwarded to the Juvenile Court for disposition.

MALICIOUS DESTRUCTION OF PROPERTY

On April 9th, at 5:52 p.m., an officer was dispatched to the 31000 block of Shiawassee for a Malicious Destruction of Property report. The reporting person stated that a friend of her son's lit one of her fence posts on fire after she asked him to leave. The post was extinguished by the resident after a passerby notified her. The resident did not actually see her son's friend ignite the fence post but suspects him. The responding officer made contact with the property owner who refused to prosecute.

OPERATING WHILE INTOXICATED THIRD OFFENSE

On April 9th, at approximately 10:30 p.m., an officer stopped a vehicle for speeding at Grand River and Sherwood. In speaking with the driver the officer noted the odor of alcohol and believed the driver to be intoxicated. The driver was unable to complete field sobriety examinations correctly and refused a preliminary breath test. The driver was arrested and transported to the station where he submitted to a breath test with a result of .23. The driver had four prior convictions for Operating While Intoxicated.

DRIVING WHILE LICENSE SUSPENDED

On April 10th, at approximately 9:30 p.m., an officer stopped a vehicle for driving erratically near Grand River and Halstead. The officer obtained a driver's license and learned that the driver had a suspended driver's license. The driver was arrested and placed in the officer's vehicle. An inventory searched revealed a fraudulent Michigan temporary driver's license along with some possible fraudulent checks. These items were confiscated for further investigation. The driver was taken to the station where he was processed and interviewed before being released. The fraudulent items will be further investigated by a detective.

WARRANTS OTHER POLICE DEPARTMENT

On April 12th, at approximately 2:22 a.m., an officer checked on an occupied vehicle in the parking lot of Starbucks. The officer learned from the state computer that one of the occupants had a warrant for his arrest out of the City of Detroit for fraud. The City of Detroit declined to pick up the man so he was released and advised to take care of his warrant.

WARRANTS OTHER POLICE DEPARTMENT

On April 12th, at approximately 3:52 a.m., a sergeant stopped a Hyundai on the M-5 expressway for a traffic violation. A subsequent investigation revealed that the man had over \$1,300 in warrants out of Farmington Hills. The man was turned over to the Farmington Hills Police Department.

JUVENILE COMPLAINT

On April 13th, at approximately 5:30 p.m., an officer spotted a fourteen year old juvenile crush a soda can and throw it into the bushes near State Street and Farmington Road. The juvenile was stopped, identified and a call was made to his parent's notifying them of the incident.

OPEN DOOR

On April 15th, at approximately 4:00 a.m., a shift commander checking the businesses downtown noted that the front door to the Village Mall was unsecured. The officer checked the businesses inside and secured the building.

POSSESSION OF MARIJUANA

On April 15th, at approximately 8:30 p.m., an officer stopped a vehicle near Grand River and Orchard Lake Road for an equipment violation. Upon speaking to the driver, the officer noted the odor of marijuana. The officer asked the driver if she had any marijuana with her. The driver stated "yes" and pulled a marijuana pipe and some marijuana out of her purse. The driver was arrested for Possession of Marijuana and transported to the station.
