The meeting was called to order at 7:00 p.m. by Mayor McShane.

ARTS COMMISSION PRESENTATION - NANCY COUMOUNDOROUS

Present: Nancy Coumoundouros, Beverly Ellis, Haroune Alameddine, Jim McGlincy and Marion Middlebrooks

Nancy Coumoundorous, Cultural Arts Supervisor, discussed a number of activities in which the Commission has participated in over the last year. She noted the success of the Youth Theatre, Arts Camp and Concert series. She expressed hope that the 2008 millage renewal would provide additional funds for the arts. She stated a survey will be sent out in the near future to determine the expectations of the community regarding the arts program.

Coumoundorous expressed the need for a performing arts center in the community. She noted the limited space available to accommodate the many arts programs.

Commission member Haroune Alameddine noted the good fortune of our community to have a culturally diverse population and thanked Council for their support of the Commission.

Coumoundorous announced this year Art on the Grand would include workshops conducted by the Detroit Art Institute.

Councilmember Knol recognized the great job Ms. Coumoundorous and the Commission are doing. She expressed the importance of collaboration with other organizations in finding venues for the arts programs.

Discussion followed regarding an appropriate venue for the arts programs. Coumoundorous noted the Cultural Arts Division is not looking for a large venue, but

rather a reasonable, multipurpose facility. She stated the Farmington/Farmington Hills community has incredible potential for being the center for community arts in this area.

Commission member Jim McGlincy stated the Commission endeavors to collaborate where possible, noting a recent meeting with Oakland Community College regarding sharing space.

Councilmember Wright expressed his gratitude to the Commission for all of their efforts. He asked if the Civic Theatre could be used as a possible venue. Coumoundorous identified some of the problems with using the Civic, but noted they have held performances there.

Discussion followed regarding changes in Art on the Grand at the Founders Festival.

Councilmember Buck stated the community is very proud of the efforts put forth by the Commission.

Responding to a question from Mayor McShane, Coumoundorous stated the Cultural Arts Division employs three part-time people, but is looking to employ a full-time person in next year's budget.

Discussion followed regarding enhancement of "Art in the Corridor" in Farmington City Hall and placement of art throughout the Downtown area to promote its walkability.

Discussion ended with the importance of "getting the word out" on the needs of the Commission relative to the 2008 millage renewal.
